

PETITION FOR RECALL

TO THE HONORABLE DANA POINT CITY COUNCIL: Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the City of Dana Point, California, respectfully state that we seek the recall and removal of Diane Harkey, holding the office of City Council Member, in Dana Point, California. We demand an election of a successor to that office. The following Notice of Intention to Circulate Recall Petition was served on July 24, 2007 to Diane Harkey.

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION. TO THE HONORABLE DIANE J. HARKEY: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the City of Dana Point, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of City Council Member, in the City of Dana Point, California, and to demand election of a successor in that office. The grounds for the recall are as follows:

Gross Failure in Ethics. You held a fundraiser for your losing Senate race at the historic Doheny House, during the same time a convicted felon was seeking your approval to subdivide the property. Now he is dismantling and moving the historic House with your approval. You intervened in a private civil matter, and pressured residents to sign away their legal rights to benefit owners of a luxury hotel. You received official government direction concluding "you may not participate in or vote" on the Town Center development because of your family's conflicting real estate holdings. However, you ignored the government warning, and participated in meetings and extended comment to the Council. You told a resident that to obtain construction variances in Dana Point, one had to "grease the right palm." You said you had "no grandiose plans to run for higher office," yet spent over \$1,135,000 running and losing for State Senate instead of doing your job here, and now you're running for Assembly. You've repeatedly used profanity during Council meetings and in private meetings with residents. You've been malicious towards us, harmed us, divided us, and failed to lead in an ethical and conciliatory, and manner respectful of our residents.
